This Guide to Distance Learning is designed to provide students and parents the necessary information they need to navigate the distance learning experience at elementary school. It includes information about program requirements, instruction, expectations, and schedules.

MVSD Mission Statement

We provide a balanced education, enabling all students to achieve academic success in an environment that fosters social-emotional development, equity, and creativity. Requirements and Guidelines

MVSD is required to take attendance during Distance Learning. The state requires a specific number of minutes per grade level (see below) of daily instruction and this may include a combination of live instruction, independent work, and/or assessments. Live interaction is required daily, and all students will receive daily interactions with their teachers. Weekly learning plans/schedules will be created and grades will be assigned. There will also be time set aside for teacher professional development and planning, outreach to students and families, social and emotional support, and community building. All students will be provided equal access to our Distance Learning educational program and support systems will be put in place for students that require interventions, both academic and socio-emotional.

Instruction

Distance learning includes both synchronous and asynchronous learning. Synchronous instruction is learning in real-time, with live interaction and instruction. Asynchronous instruction is learning that occurs when learning occurs independently and allows students to work at their own pace.

During distance learning, all assignments, activities, directions, resources, and any instructional videos will be posted in either Google Classroom, Seesaw or Google Sites. Teachers will create instructional (essential) standards-based assignments that encompass a progression of learning. This includes enrichment, engagement, intervention, remediation and exposure to new material. Teachers will be responsible for creating instructional activities that meet the needs of their students.

Administrator, Counselor, and Support Staff

- Ensure students, families, and staff have the necessary materials and equipment to succeed.
- Provide staff with tools and training needed to provide successful distance learning.
- Share school and district-wide news with the learning community

Weekly Schedule

Teachers will devise their own schedule within the bell schedule. Classes will start at or near the first bell of the day. The end time of the school day will vary by class due to a number of factors: the SB98 minutes required by grade level, the distribution of synchronous and asynchronous minutes throughout the school day, and the timing of specialist classes (PE, Music, Library, Art). Your child's weekly schedule will denote start and end times. Math, Reading Workshop, Writing Workshop, Social Studies and/or Science will be scheduled. Each student will receive 30 minutes of Art, Library and Music weekly, and PE daily (1 time per week for Kindergarten).

During regular periods in remote instruction, students will participate in whole group, small group, and individual learning. Students will also be assigned instructional activities and/or other projects and assignments they can complete during asynchronous learning time. Additionally, Wednesdays will be an "early release" just like our typical schedule so that our teachers can meet, plan, and collaborate. In order to provide a robust, rigorous, and meaningful remote learning experience for our students, it is important we build-in time for teachers to work together.

Zoom Guidelines

Zoom is the Mill Valley School District's supported video conferencing tool for "live" interaction and instruction with teachers. Its purpose is to create a learning-centered environment. Students are expected to behave as if this were a regular classroom setting, in a respectful and responsible manner. All school rules, teacher guidelines and expectations apply.

- The introduction of new content and standards may be introduced during a live Zoom session.
- Sessions may also be used for connecting with students, providing extension activities, answering any questions, or clarifying instructional activities.
- Zoom sessions may only be recorded with explicit written teacher and administrator permission.

Student	 Prepare a quiet space for class with all necessary materials, that is free from distractions for yourself and others Access the Zoom meeting information as directed by your teacher When on screen, be seated in a learning space and ready to participate Camera should be on at all times unless agreed upon with the teacher Teacher and/or school approved virtual backgrounds may be used Backgrounds may not be changed without permission during a Zoom session Place yourself on mute when not talking Join the class session with your first and/or last name only. Attendance is required Close unneeded applications on your device to optimize video quality Posting, streaming, screen shots, screencasting, or otherwise sharing or commenting on any element of an online class without permission is not allowed

	 Privately "chatting" to other students in the class, or otherwise distracting others is not allowed Attempting to disrupt the teacher or other students is not allowed In the event multiple students are in the same learning space, each student must have their own device and all students must use headphones
Parent	 Expect that child will attend all class sessions Ensure that child has a quiet space with materials ready to attend the class Classes are for student participation only Encourage child to communicate any feedback or questions to the teacher Please be patient and understanding as we are all in this together Ensure that if there is a tutor or other individual supporting learning in a student's learning space, that the tutor or other individual supporting learning will not interact in any way with the Zoom session or teacher.

Attendance Policies

Homeroom teachers will take attendance daily. Please contact the school office prior to 9:00AM to report your child's absence.

Student Conduct

Being Safe, Respectful, Responsible and Kind

Elementary School students are expected to maintain a welcoming and safe learning environment for everyone. Students are to respect themselves, their peers and staff members by being kind, honest and truthful. *Any form of cyber and/or online bullying and harassment will not be tolerated.*

Being Safe and Responsible

All students are expected to conduct themselves in a safe and responsible manner while in a classroom zoom session and when working independently on instructional activities. Students are to create a learning space at home that is free from distractions. Making inappropriate, rude, or disrespectful comments in a classroom Zoom session or any other communication platform toward any staff or students will not be tolerated.

Arriving to Classroom Zoom Sessions on Time

All students are expected to attend regular classroom Zoom sessions as scheduled, and be punctual.

Using iPad & Technology

All students who are issued an iPad are expected to use the device in an educational manner as directed by their teacher, and to adhere to the 1:1 iPad Program Agreement.

Dressing for Learning

Elementary School students are expected to dress appropriately for the learning environment. While in a classroom Zoom session, it is important to show respect to themselves, peers, adults, and teachers by wearing clothing that is activity appropriate and conducive to learning.

Personal Electronics During Distance Learning

All personal electronic devices are to be turned off (not silent or vibrate) at all times during the classroom Zoom session, AND stored away from the student's home learning area.

Addressing Student Conduct

The Mill Valley Elementary School administration and staff make every attempt to create a safe and positive online school environment free from disruptions that interfere with teaching and learning activities. During this time, all Mill Valley Elementary School rules, expectations, and guidelines are still in effect. We expect our students to continue to be: *Safe, Respectful, Responsible and Kind*.

Teachers will work with individual students and families to address specific needs and behavioral concerns, if they arise. If a school rule is broken teachers and/or administrators will guide students in making better choices about their behavior in the future. Parents/guardians will be notified when a student has been referred to the administration for incidents which result in a consequence.

One of the ways we educate students about their behavior is through Restorative Practices. Our main goal is for students to change their behavior. This type of intervention is done in lieu of traditional consequences, and parents are also involved. When students are referred to the administration for the behavior, restorative practices are usually given. These practices (or consequences) may include research assignments, letters of apology, and counseling.

Communication Platforms

During the course of the school year, we have a number of communication platforms used to communicate events, information, announcements, celebrations, and all things related to our school community to students, staff, and families. Please see the description of each platform and the expectations of administration, teachers, students, and families.
