Insure clamping ring sandwiches System. Furnish and install [n] bolts and washers. Secure ring evenly. Re –install strainer and secure.

 Baseflashings in designated locations. Furnish and install [n]
 Flat Aluminum pre slotted termination bar. Fasten twelve [12]
 O.C. with washered fasteners @ the bottom of the interior of the coping.
 Cover bar completely with [n] fluid applied system.

 Add: Letter V- At the end of the existing expansion joints, neatly trim
 Granulated cap sheet back a minimum of three [3] inches to expose
 end /underlayment. Clean and prime surfaces to include metal. Apply
 Base, reinforcement and top coat to provide a watertight seal at ends
 onto metal cap. Tie system onto metal at areas where they intersect.
