## Pesticide Notification

August 2018

Dear Parent or Guardian:

The Healthy Schools Act of 2000 requires that all schools provide parents or guardians of students with annual written notification of expected pesticide use on school sites during the year. The District makes every attempt to resolve pest and weed issues without the use of pesticides and herbicides.

### **Mill Valley Parks and Recreation Department:**

The City of Mill Valley Parks and Recreation Department maintains the fields adjacent to Edna Maguire and Mill Valley Middle Schools, we are providing you with information on the pesticides it may use. Although rarely used, if necessary, the City would schedule application over school breaks when the fields are closed. ### **Marin/Sonoma Mosquito & Vector Control District**

The Marin/Sonoma Mosquito & Vector Control District inspectors review our campuses for adult and larvae mosquitoes and if found would then notify the Mill Valley School District of their intent to treat the affected areas.

Treat the adult mosquitoes	Pyrocyde®	Pyrethrum
Treat larvae in standing water	Altosid®	Methoprene

### **Mill Valley School District:**

The Mill Valley School District maintains the grounds at all school sites. Although rarely used, if necessary, the District would schedule application over school breaks when the schools are closed.

Parents or guardians may request prior notification of any pesticide applications at sites. Once the District receives any notification from the above agencies that a product may be applied, we will inform people in the registry at least 72 hours before an application is made.
